WE GENERATED OVER 8,000 VOLUNTEER HOURS IN 2014. THESE VOLUNTEERS ASSISTED WITH PLANTING, INVASIVE REMOVAL, RIVERBED CLEAN UPS AND A VARIETY OF OUTREACH AND SPECIAL EVENTS.
